

MINUTES of Town of Vermilion Library Board October 26, 2022 @ 7pm

1. Call to order: An annual general meeting of the Town of Vermilion Library Board was called to order at 7:00pm at the Vermilion Library, Justin Thompson chairing.

- 2. Agenda: Alva moves the adoption of the agenda. Carried.
- **3. Minutes:** Add Kirby to previous minutes, Josh moves the adoption of the minutes as amended. Carried.
- **4. Elevator Proposal:** UCG showed some mock-ups and rough schematic drawings of 2 locations for an elevator in the library. Board will consider locations once full tenders files are given.
- 5. Chairperson Report: A highlight of achievements in the 2022 concerning our service plan:
 - 1. Know your community: recorded 6,095 website sessions
 - 2. Support & Enhance Sustainability: Completed Ramp project, started elevator project
 - 3. Foster and Satisfy Curiosity: Hosted 15 networking events
 - 4. Connect to Digital World: Purchased 3 emerging tech items for loan
 - 5. Create New Readers: We average 18 kids a week in literacy programs
- **6. Library Usage Report:** A high level statistical overview was presented on library usage. 722 cardholders borrowed 37,250 items. Average user borrows \$1,016 worth of material per year.
- 7. Financial Report: A summary of finances to date and the budget for 2023 was presented.
- **8. Bylaws & Policies:** Alva presented recommended changes to operating policies and bylaws. All changes were minor corrections in nature aside from a recommendation to adopt Revenue Canada standards for travel costs and mileage. Alva moves the adoptions of the bylaws as presented. Maxine seconds. Carried. Alva moves the adoption of the policies as presented. Carried
- **9. Elections:** Joan nominates Justin for chairperson. No other nominations received. *Justin is named chairperson by acclamation*. Kirby nominates Anna for treasurer. No other nominations received. *Anna is named treasurer by acclamation*. Joan nominates Maxine as vice chair. No other nominations received. *Maxine is named vice chair by acclamation*. *Josh moves the library board update signing officers on all accounts to include Anna, Justin, and Maxine*. *Carried*.
